ANNOUNCEMENT POWER GENERATION FOR OCTOBER 2025

This announcement is made pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Cap. 571, Laws of Hong Kong).

The power generation of China Longyuan Power Group Corporation Limited* (the "Company", together with its subsidiaries, collectively the "Group") for October 2025 on a consolidated basis amounted to 5,605,173 MWh, representing a year-on-year decrease of 4.95% as compared with the corresponding period of 2024. During the month, the wind power generation registered a year-on-year decrease of 12.14%, and PV power generation registered a year-on-year increase of 52.86%.

As of 31 October 2025, the total power generation of the Company for 2025 amounted to 62,151,880 MWh, representing a year-on-year decrease of 0.94% as compared with the corresponding period of 2024, excluding the impact of coal power, representing a year-on-year increase of 11.82%, in particular, the wind power registered a year-on-year increase of 3.44%, and PV power registered a year-on-year increase of 75.45%.
